

Privacy Policy

This privacy policy describes our policies and procedures on the collection, use and disclosure of your information when You and the service and tells You about Your privacy rights and how the law protects You.

We do not use any Personally identifying data to provide and improve the service. By using the App, You agree to this Privacy Policy.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy;

App or Application means the software program provided by the Company downloaded by You on an electronic device, named Spare Mic

Website means the website

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Synergie Tech, Inc.

Country refers to: Delaware, United States

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Application.

Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

Collecting and Using Your Personal Data

Types of Data Collected

Personal data

App Usage Data

The App does **not** automatically collect any personally identifying information that can be used to contact or identify you. However, if you chose to, you may share Usage Data.

For the App Usage Data is **not** collected automatically and requires You to give Apple permission to share data with the developer when there is a bug, crash or unexpected functionality.

For the App Usage Data may include Your device type, When the bug, crash or unexpected functionality occurred, App version, App build, Device type or Your region. We do not directly collect any of this information, but may receive it from Apple if you have opted in. Apple does so anonymously. Website Usage Data

For the Website Usage Data is collected automatically which may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that You visit, the time and date of Your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When You access the Website by or through a mobile device, We may collect certain information automatically, including, but not limited to, the type of mobile device You use, Your mobile device unique ID, the IP address of Your mobile device, Your mobile operating system, the type of mobile Internet browser You use, unique device identifiers and other diagnostic data. We may also collect information that Your browser sends whenever You visit our Service or when You access the Website by or through a mobile device.

Information Collected while Using the Application

You can enable or disable access to this information at any time, through Your Device settings.

Use of Your Personal App Data collected by the App

The Company may use Personal Data for the following purposes:

- **With Your consent:** We may disclose Your personal information for any other purpose with Your consent.

[Retention of Your Personal Data collected from the Website](#)

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.
